# Bundaberg Greyhound Assistance Fund (BGAF)

The fund will provide financial assistance to eligible trainers who are unable to race locally in Bundaberg as a consequence of the circle grass track no longer having programmed meetings.

Eligible trainers will receive \$40 per week per eligible greyhound.

The fund will be available for a three-month period, commencing February 17, 2025 until May 17, 2025.

#### Instructions

Please complete the form below to apply for funding through the BGAF.

Claims must be for a minimum of four weeks and can only be lodged after a four-week claim period has ended.

Claims of less than four weeks will be permitted if the greyhound is transferred during the claim period.

A new application form should be submitted for each claim period.

The final claim period may be less than four weeks.

# Who is an eligible trainer that can apply for Greyhound Assistance Funding?

The applicant must be the licensed trainer responsible for the care of an eligible greyhound.

The applicant must reside in the Bundaberg region to be an eligible trainer.

The Bundaberg region is defined as Gympie (postcode area 4570) to Seventeen Seventy (postcode area 4677).

The applicant must not have had any greyhound in their care race in an event since October 1, 2024.

#### What is an eligible greyhound?

An eligible greyhound must meet the following criteria:

- a) The greyhound was in the care of the eligible trainer for the period of claim; and
- b) Had raced at Bundaberg at least once between April 1, 2024 and September 30, 2024, whilst in the care of the eligible trainer.

Unraced greyhounds, breeding and retired greyhounds are not eligible.

# Exemptions

An exemption to receive the BGAF may be provided in an exceptional circumstance at the sole discretion of Racing Queensland. The applicant must detail the exceptional circumstance in writing for Racing Queensland to consider. All application decisions made by Racing Queensland are final.
