## FASHIONS FROM AFAR FINAL – COMPETITION FINAL CONDITIONS OF ENTRY

- 1. Regional Finalist in both Female and Male categories are invited to attend the Fashions from Afar Final to be held on Saturday, 28 June 2025 Tattersall's Tiara Race Day hosted by Tattersall's Racing Club at Eagle Farm Racecourse ("**Final**").
- 2. The entry conditions, judging criteria and prizes relating to the Regional Qualifier will be determined and administered at the sole discretion of the Participating Club. Racing Queensland does not accept any responsibility or loss suffered in connection with the Regional Qualifier.
- 3. To be eligible to compete in the Final, the nominee must:
  - a. Be at least 16 years of age; and
  - b. First win (or Runner Up, refer clause '6) a Fashions From Afar competition held by a race club (Participating Club) during their race meeting as part of the Batte of the Bush Series (Regional Qualifier).
- 4. The Participating Club must, by the first Monday immediately following the Regional Qualifier, notify Racing Queensland via <u>rsvp@racingqueensland.com.au</u> of:
  - a. The winner of the Regional Qualifier for both the male and female categories (including their full name, mobile number and email address) (**Finalists**); and
  - b. The Runner Up of the Regional Qualifier for both male and female categories (including their full name, phone number and email address) (**Runner Up**).
- 5. All Finalists must confirm with Racing Queensland their attendance at the Final by June 13, 2025.
- 6. Should regional Finalist elect not to attend the Final event, the regional Runner Up will be offered the opportunity to attend and compete. No prizemoney from the qualifier event, or subsidy towards attending the final will be provided, all associated costs incurred with competing in the final will be responsibility of the participant.
- 7. Racing Queensland reserves the right to reject the nomination of a Finalist for any reason that it sees fit. Racing Queensland will provide reasons to the Finalist for its decision to reject the nomination.
- 8. Racing Queensland will provide entry into Eagle Farm Racecourse for all Finalists. Finalists must abide by all patron conditions of entry of Eagle Farm Racecourse.
- 9. No subsidies will be paid to participants to participate in the Final in Brisbane and all costs associated with Final participation (including travel, accommodation and any related expenses) will be the responsibility of the participant. Racing Queensland accepts no responsibility for costs incurred due to unforeseen circumstances, including but not limited to travel cancellations, accommodation issues or personal emergencies.
- 10. Should a Finalist elect not to attend the Final, the Runner Up will be offered the opportunity to attend and compete in the Final.

- 11. A person who is a Winner or Runner Up of the Final is not permitted to enter or participate in any Tattersall's Tiara Race Day Fashions on the Field events or similar Brisbane Racing Club fashion competitions at Eagle Farm Racecourse on the day of the Final.
- 12. Employees, directors and other representatives of Racing Queensland are ineligible to participate, as are members of their immediate families and households.
- 13. Neither Finalists nor their outfits are permitted to commercially promote a brand, store, or designer. A commercial entity is defined as a business that operates out of a physical storefront or online business that commercially profits from sales of Fashions related clothing or accessories. For removal of doubt the business must be presently operating in a full capacity.
- 14. Fashions from Afar fashion Final competition will be judged based on the following criteria:
  - Appropriateness of outfit for the conditions on the day (climate/weather); a.
  - b. Appropriateness of outfits for Fashions on the Field (appropriate formal daywear);
  - c. d. Style and originality of the outfit;
  - Attention to detail (millinery, accessories, shoes);
  - e. Understanding and interpretation of the current fashion trends without losing the entrant's personal flair; and
  - f. Hair, make-up and confidence (something that makes them stand out in an appropriate manner).
- 15. A Finalist (or a Runner Up) may be refused entry into the Final if the Finalist does not comply with any law, policy or regulation, does not meet one or more of the judging or eligibility criteria or breaches these terms and conditions.
- 16. Racing Queensland or Tattersall's Racing Club will select the judging panel and each validly entered Finalist will be judged based on the judging criteria (as interpreted by the judges in their absolute discretion). The judges' decision is final. In the event of a draw, Racing Queensland will determine the winner.
- 17. The Final will consist of the following competitions and prizes:

Female Fashions from Afar Final	Male Fashions from Afar Final
1 <sup>st</sup> Prize - \$2500	1 <sup>st</sup> Prize - \$2500
2 <sup>nd</sup> Prize - \$1000	2 <sup>nd</sup> Prize - \$1000

- 18. The Final Prize will be paid by Racing Queensland within 14 days of completion of the Final.
- 19. Any Finalist or Runner Up must not disparage or make derogatory comments about Racing Queensland or any other Finalist or Runner Up. Racing Queensland may disqualify a person from competing in the Final if, in the opinion of Racing Queensland, that person has engaged in dissatisfactory conduct.
- 20. If for any reason after a Finalist has won prizemoney, and Racing Queensland or Tattersall's Racing Club become aware that the Finalist has not complied with the terms and conditions or that their entry is otherwise invalid, that Finalists will have no entitlement to the prizemoney, even if Racing Queensland or Tattersall's Racing Club have announced them as a winner and that Finalist will be required, at the direction of Racing Queensland or Tattersall's Racing Club, to return, refund or otherwise make restitution of the prizemoney.
- 21. Finalists' agree that their image, name, character, likeness, voice or anything else that identifies them for the purposes of any promotion or matter incidental to any Fashions From Afar or racing event, including future similar promotions, and at any time during or after the competition and via any means (including but not limited to, any national print media, the Racing Queensland or Tattersall's Racing Club's website and any other promotional material) may be used by Racing Queensland or Tattersall's Racing Club and their sponsors for future promotional and publicity purposes without any compensation or reward.
- 22. Racing Queensland reserves the right to amend these Conditions of Entry of make exceptions to any of the eligibility criteria at its sole discretion. Such decisions will be final and binding.
