3. FEES & PAYMENTS SCHEDULE - GREYHOUNDS

3.1. Fees

RQ does not currently charge any fees for Greyhound Racing, including but not limited to nomination fees or scratching fees.

3.2. Payments

4. **PRIZEMONEY**

- (a) Prizemoney will be as detailed in the RQ racing calendar (as amended from time to time). Prizemoney will be paid by the RQ in accordance with the Rules of Racing for the code of racing or otherwise in accordance with RQ practice.
- (b) It is RQ's present intention to maintain its current weekly prize money payment schedule which includes:
 - (i) Harness racing on Tuesday;
 - (ii) Greyhound racing on Wednesday; and
 - (iii) Thoroughbred racing on Thursday.

5. INCENTIVE AND BENEFIT SCHEMES

RQ maintains a number of schemes, details of which are uploaded on the RQ website from time to time, including:

- (a) QTIS: Queensland Thoroughbred Incentive Scheme
- (b) QBRED: Breeder and Owner Incentives for Pacers and Trotters
- (c) Industry Sustainability Payments; Owner' Trainer; Breeder Incentives for greyhounds
- (d) Race Meeting Injury Scheme (Greyhounds)
- (e) Maternity Support Scheme: Jockeys and Drivers

6. GST

- (a) The GST treatment of individual payments depends on the type of payment. See details above.
- (b) Participants must declare their GST status, and participants registered for GST will be paid GST.
- (c) No GST will be paid to any participant not registered for GST.

7. FURTHER DETAILS

- (a) Individual race clubs may charge their own fees for the use of their facilities and services.
- (b) Except as otherwise set out, fees are payable by the relevant trainer.
- (c) Prizemoney will be distributed as set out in the Rules of Racing of the relevant code of racing.
